

INVITING APPLICATIONS UNDER PRIME MINISTER **EMPLOYMENT GENERATION PROGRAMME (PMEGP) TOWARDS ESTABLISHMENT OF MICRO ENTERPRISES**

Khadi and Village Industries Commission (KVIC) is implementing Prime Minister Employment Generation Programme (PMEGP) through State/Divisional Offices of KVIC, State/Union Territories Khadi and Village Industries Boards and District Industry Centers (DIC). The objective of the scheme is to provide employment opportunities by setting up of Micro Enterprises in rural and urban areas. Scheme details can be viewed on KVIC website, www.kvic.org.in

Margin money subsidy ranging from 15% to 35% is available depending on category of beneficiary/area of beneficiary. Maximum cost of the project per unit admissible under manufacturing is up to ₹ 25.00 lakhs and for business/services sector it is up to ₹ 10.00 lakhs.

Applications are invited from:

- 1) Unemployed above the age of 18 years.
- 2) Self Help Groups (SHGs).
- 3) Registered Institutions.
- Co-operative Societies.
- 5) Trust etc.

Above individuals/institutions may apply in the prescribed format which can be downloaded from websites, www.kvic.org.in and www.msseweb.org or the same can be collected from local offices of KVIC, KVIB and DICs.

KVIC and KVIB will be operating the scheme only in rural areas whereas DIC will be operating the scheme in rural and urban areas.

Existing units or applicants who have already availed subsidy/margin money under PMRY/REGP/PMEGP or any other Central/State Subsidy Scheme are not eligible. Only one person from one family is eligible for obtaining financial assistance under the scheme.

HOW TO APPLY

- 1. Applicants eligible as per the scheme guidelines can either apply online by logging on to www.kvic.org.in or
- 2. They can approach local offices of KVIC or KVIB or DIC

Interested persons may apply within 15 days to any of the three agencies viz. Khadi & V.I. Commission (KVIC), Khadi & V.I. Board (KVIB) & District Industrial Centers (DIC) from the date of advertisement.
