## Expression of Interest (EoI)

Expression of Interests (EoIs) are hereby invited from reputed concerns, Agencies, Merchants, Traders, Exporters, Khadi Institutions, Handloom Cooperatives, Textile Mills, Garment Units, Export Houses, Buying Agencies, Retailers etc having adequate capacity to consume the cotton yarns and fabrics in bulk volume from various production units of WBKVIB within 26/12/2023 observing the following terms and conditions.

- Intended concerns should be registered properly under Companies Registration Act, Cooperative Act, Society Registration Act etc. In the case of Agencies, Merchants, Individuals valid license from the appropriate authorities should be possessed.
- Intended party may visit either the office in the address captioned above or may visit the production units within any working day before 26/12/2023.
- Necessary credentials, Trade License, Balance Sheet of last three (3) Years preferably, Professional Tax, GST Registration, IT Return of last FY etc should be enclosed with the EoI.
- The intended concerns will be at liberty to either consume the entire volume of fabric and yarns or purchase part of entire volume.
- The statement of entire stocks of yarn and fabric made of pure cotton produced in various production units of WBKVIB is attached here with for a ready reference of the intended parties.
- For any further query intended party may visit the office or may contact in the Phone no: 8335060744
- Intended parties should specify the exact quality and quantity of material to be consumed by selecting them from the stock. They should also specify the price which will be offered by them for purchase of yarns and fabrics. They should clearly mention the rate of offered price in the form of '**rupees per kg**' for yarns and '**rupees per Than of 11 meters**' for fabrics.
- The authority will reserve the right to accept or reject any EoI without ascertaining to any reason.
- An empowered committee will take the final decisions for accepting the EoIs. More than one intended parties may also be selected by this empowered committee to allow them to purchase the materials from WBKVIB.
- After final selection of the intended parties a primary acceptance letter will be provided to them specifying the rate, quantity and quality to be consumed by the parties in specific. On receiving this letter the selected parties should deposit 50% of the total amount within 15 days. After successful delivery of the selected items to a party from WBKVIB the rest 50% of payment should be done by the party.
- No transport charge will be borne by WBKVIB. Transport of material should be arranged by the selected party.

1. After issuance of primary acceptance letter the entire process of purchase of material and payment thereof should be completed within a span of time of 1 month only. For any abnormal delay the Authority shall possess the right to cancel the acceptance letter by deducting 10% of the purchase value from the deposited amount.

The EoIs so received will be opened on 29/12/ 2023 at 2:00 PM at the office chamber of undersigned. Intended parties may remain present during opening of the EoIs. Final decisions will be taken within a few days by the empowered committee in this regard.
