- Latest professional Tax Paid Challan & P-Tax Enrollment Certificate, Professional Tax Payment Certificate.
- Valid 15-digit Goods and Services Taxpayer Identification Number (GSTIN) under GST Act, 2017 & Latest
- GST Return in Form No. 3B.
- Latest Valid Trade License.
- Work Order along with Payment Certificate, Completion certificate for the work in technical credential.
- Affidavit before Notary mentioning the NIT No. as well as the correctness of the documents and declaration of penalty, debarment etc.

2. Other Terms & Conditions: -

- Pan Card, Professional Tax receipts Challan for the Year 2021-22, Current GSTIN registration Certificate along with current GST payment receipt to be accompanied with the Technical Bid document. Income Tax (SARAL) Acknowledgement Receipt for assessment year (2021-2022) to be submitted.
- Bidder must have office in West Bengal.

3. Self attested (by the bidder) Pan Card, GST Registration, Smart Card of the vehicle, Road Tax, updated Pollution Certificated, Updated Insurance Coverage etc. are to be enclosed along with the quotation.

4. Notice Documents of quotation will be available at the e-Quotation Portal (<https://wbtenders.gov.in>) of the West Bengal, above mentioned date and time. Notice of this quotation will also be displayed in the Official website of WBKVIB at www.wbkvib.org.in.
 5. Schedule of e-quotation: BOQ available at e-Quotation portal of the West Bengal
 6. Formats and values to be put in the quotation should be as per the BOQ. Rates are to be given for two types of vehicles.
 - Office Car (Swift Desire, Bolero, Scorpio, Marazzo, Innova, etc.)
 - Commercial Goods Vehicles [Tata ACE / Mahindra Jeeto Plus / Mahindra Supro Mini Truck, Tata 407 / Mahindra Furio7/ Loadking Optimo etc.]
 7. **Necessary Credentials, Certificates of previous works of similar nature should be enclosed. Highest Credentials may be preferred.**
 8. All the rates are to be mentioned covering all the permissible charges including GST. No extra charge will be permitted to be added in future.
- a.
 - b. The Bid should be submitted in two parts digitally super scribing "TECHNICAL BID" and "FINANCIAL BID". FINANCIAL bid of only those bidders shall be opened who are technically qualified on evaluation according to the predefined qualification criteria as mentioned in this N.I.E.T by the 'Tender Committee' formed for the purpose. The decision of the 'Tender Committee' will be final and absolute in this respect. The list of Qualified Bidders will be displayed in the Notice Board of this Office on the scheduled date and time as mentioned Tender Notice.
 - c. Issuance of work order as well as payment will depend on availability of fund and no claim whatsoever will be entertained for delay of Issuance of work order as well as payment, if any. Intending tenderers may consider these criteria quoting their rates.
 - d. Defect Liability Period mentioned in Tender Notice front page**
 - e. Adjustment of price (increase or decrease): - No escalation of cost will be allowed even in extension period of time, granted by WBKVIB.
 - f. Price preference will not be allowed.
 - g. from the date of completion of the work and recommendation of Project Engineer.
 - h. The Chief Executive Officer, WBKVIB reserves the right to cancel the Tender Notice due to unavoidable circumstances and no claim in this respect will be entertained.
 - i. Before issuance of the work order, the tender inviting authority, may verify the credential & other documents of the lowest Quotational if found necessary. After verification, if it is found that such documents submitted by the lowest tenderer is either manufactured or false in that case, work order will not be issued in favor of the tenderer under circumstances.
 - j. The intending tenderer is required to quote the rate in figures as well as in words as percentage above / below than or at per with the relevant price schedule of rates.
 - k. No CONDITIONAL / INCOMPLETE TENDER will be accepted under any circumstances.
 - l. In case of Quoting rates, no multiple lowest rates will be entertained by the Department.
 - m. Qualification Criteria.

The Tender Inviting & Accepting Authority through a 'Tender Committee' will determine the eligibility of each bidder, the bidders shall have to meet all the minimum criteria regarding: -


a) Financial Capacity b) Technical capability c) Experience

The eligibility of a bidder will be ascertained on the basis of the self-attested documents in support of the minimum criteria as mentioned in a, b, c above, and the declaration executed through prescribed affidavit in non-judicial stamp paper of appropriate value duly notarized in Annexure -X. If any document submitted by a bidder is noticed either manufactured or false, in such cases the eligibility of the bidder/ tenderer will be outrightly rejected at any stage without any prejudice. The bidder would also be liable for the criminal proceeding as per law.

NB- All the above documents are to be submitted in separate .pdf file properly named with a forwarding letter in company letter head pad addressed to the CEO, WBKVIB listing all the documents submitted online. The letter head must contain full address telephone no / Mobile No. and e-mail ID. No other papers are required.

9. Estimate of the work (BOQ) is attached herewith. The same is to be submitted as financial bid.

7. Intended quotationers submitting EOI should specifically mention the quantum of charges for rendering services for conducting the e-auction process for disposal old stock of khadi items.




