Reference is invited to the above mentioned circular, wherein, the enhancement of wages of spinners from Rs. 3/- per hank to Rs.4/- per hank to be incorporated in the revised cost chart w.e.f. 01.04.2014 & weavers by 5% to 10% (exact amount to be decided at State Level) w.e.f. 01.04.2014 and also the wages of other artisans where the exact amount of increase shall be decided at the State Level and effective from 01.04.2014 was communicated for compliance of all concerned.

- 2. While confirming the minutes of the meeting, Commission took note of observation of Expert Member (HRD) and deliberated on the above issue once again in its 622nd meeting held on 12.02.2014 and the decision shall now read as under:
- (i). the present Commission in its 620th meeting held during December 2013 has taken a decision to enhance wages of spinners from Rs.3/- per hank to Rs.4/- per hank with effect from 01.04.2014.
- (ii). Commission also decided to enhance wages of weavers by 5% to 10% with effect from 01.04.2014.
- (iii). Commission has also decided to enhance wages of all other artisans by 5% to 10% where the exact amount of increase shall be decided at the State Level effective from 01.04.2014.
- 3. All State and Divisional Directors are hereby requested to note the decision of the Commission and communicate to all concerned for immediate compliance.
